

# Factsheet OEKO-TEX® RESPONSIBLE BUSINESS

#### Implementing due diligence - responsibility in global business operations

A certified OEKO-TEX<sup>®</sup> RESPONSIBLE BUSINESS company looks beyond its own operations and ensures high standards throughout its global supply chain. A company that has been awarded this certification is committed to due diligence and protects both human rights and the environment.

### **Product description**

OEKO-TEX<sup>®</sup> RESPONSIBLE BUSINESS enables a holistic consideration of due diligence measures into companies management systems and consists of seven elements:

- Embedding responsible business practices into companies' policy and management systems.
- Mapping supply chains and identification of risks in the companies supply chain followed by a prioritization.
- Integration of appropriate actions and measures to avoid potential risks and to remedy adverse impacts.
- Monitoring of set measures and adjustment where necessary.
- **Communication** to all stakeholders on the due diligence process, including the results of the risk analysis, complaints received and the measures taken to address potential and remedy actual adverse impacts.
- Implementation of a grievance mechanism.
- Developing strategies supporting the Paris Climate Agreement.

## The evaluation for module 1-6 views the implementation of due diligence obligations into the supply chains based on three different levels:

- Level 1: Minimum implementation of due diligence obligations within the supply chain (own business operations, 100% direct suppliers), incl. transport & logistics until delivery to end customer.
- Level 2: Good implementation of due diligence obligations within the supply chain with further optimisation potential (Level 1 + indirect suppliers), incl. transport & logistics until delivery to end customer.
- Level 3: Best Practice implementation of due diligence obligations within the supply chain (Level 2 plus + deeper supply chain), incl. transport & logistics until delivery to end customer.

The assessment of module 7 evaluates the status of the development of a climate strategy in the company and its degree of implementation. The assessment of module 7 is voluntary and the certification of due diligence (modules 1-6) is not influenced by module 7.



OEKO-TEX® RESPONSIBLE BUSINESS is structured into two successive elements: An initial self-assessment tool and a certification process.

- 1. In a first step, answering a questionnaire enables companies to assess the status quo of their due diligence obligations.
- 2. In a second step and in order to communicate OEKO-TEX® RESPONSIBLE BUSINESS, the questionnaire is evaluated by an OEKO-TEX® testing institute and validated by an audit. After successful completion, a report, certificate and label are issued.
  - B2B communication: RESPONSIBLE BUSINESS certifies the business processes with regard to the due diligence measures implemented. It enables companies to promote the certification with a label within their corporate communication.
  - B2G communication: The certification facilitates reporting to authorities.

### How to receive OEKO-TEX® RESPONSIBLE BUSINESS

- 1. Complete the application form as provided on the OEKO-TEX® website.
- 2. After receiving the access data of your responsible OEKO-TEX® institute, complete the self-assessment.
- 3. The Institute evaluates the information and documents submitted.
- 4. The Institute verifies the data obtained in the form of an on-site audit at the company.
- 5. The OEKO-TEX<sup>®</sup> Institute prepares a detailed audit report with a final evaluation and issues the OEKO-TEX<sup>®</sup> RESPONSIBLE BUSINESS certificate.

### Validity

The OEKO-TEX® RESPONSIBLE BUSINESS certificate is valid for 3 years. Compliance audits need to be performed on an annual basis.
